STORYTIME PROGRAM

OUR STORYTIME PROGRAM OFFERS ELEMENTARY SCHOOL FIELD TRIPS TO OUR BOOK BANK FOR CHILDREN TO MEET AND INTERACT WITH PUBLISHED CHILDREN'S BOOK AUTHORS AND ILLUSTRATORS. THE AUTHORS READ ALOUD, HOLD DISCUSSIONS WITH CHILDREN ABOUT READING AND WRITING, SIGN THEIR BOOKS, AND TEACH ILLUSTRATION. WE GIVE THE CHILDREN FREE SKETCH BOOKS WITH LINES FOR TEXT AND COLORED MARKERS TO USE DURING THE FIELD TRIP AND THEN TAKE HOME TO KEEP. THE STUDENTS ARE ENCOURAGED TO WRITE AND ILLUSTRATE THEIR OWN BOOKS WITH THE PROVIDED ART SUPPLIES. THEY ARE ALSO GIVEN THE OPPORTUNITY AFTER MEETING THE AUTHOR TO SELECT FREE BOOKS FROM THE BOOK BANK FOR THEMSELVES, THEIR SIBLINGS, AND TO TAKE THE BOOKS HOME IN TOTE BAGS WE PROVIDE, DECORATED WITH CHILDREN'S ART FROM PREVIOUS FIELD TRIPS. FOR EXAMPLE, ONE STORYTIME FIELD TRIP WAS LED BY CHILDREN'S BOOK AUTHOR MAC BARNETT, THE LIBRARY OF CONGRESS'S NATIONAL AMBASSADOR FOR YOUNG PEOPLE'S BOOKS, 2025-2026. IN 2025, WE HELD 5 STORYTIME FIELD TRIPS FOR PUBLIC ELEMENTARY SCHOOL CLASSES AT OUR BOOK BANK AND DONATED APPROXIMATELY 1,000 BOOKS TO THE CHILDREN AND THEIR TEACHERS, ALL OF WHICH THE CHILDREN SELECTED THEMSELVES. THE STORYTIME PROGRAM IS OFFERED ENTIRELY FREE OF CHARGE.

COMMUNITY OUTREACH PROGRAM

SOME ORGANIZATIONS SERVING CHILDREN WHO NEED BOOKS CANNOT COME TO THE BOOK BANK DUE TO ECONOMIC RESTRAINTS. A PROJECT PART-TIME STAFF MEMBER LIAISES WITH THE ORGANIZATION'S STAFF REGARDING THE TYPES OF BOOKS NEEDED FOR THEIR CHILDREN, AND THEN CURATES THOUSANDS OF BOOKS, SELECTING THEM FROM THE BOOK BANK OR PURCHASING BOOKS. A VOLUNTEER OR PART-TIME STAFF MEMBER DELIVERS THE REQUESTED BOOKS AND NEATLY ARRANGE SHELVED BOOKS ON AN ONGOING BASIS (SHELVING PROVIDED FREE AS WELL, IF NEEDED). IN 2025, STAFF AND VOLUNTEERS IDENTIFIED AND REGULARLY STOCKED OVER 30 LOCATIONS, INCLUDING PUBLIC HEALTH CLINICS AND OTHER COMMUNITY ORGANIZATIONS WITH BOOKS THAT BEST MEET THE NEEDS OF THEIR CONSTITUENCIES.

INTERNSHIP PROGRAM
